- 3 Definitions

Workplace procedures refer to the verbal and written procedures on safety and operation set down by the employer or organisation.

Dispositions – action of ensuring examined animal material that has abnormalities is managed in accordance with legislative requirements.

- In the context of this unit standard, *understanding* means that there should be evidence of a learner's thorough comprehension of a topic. A learner with a good understanding of a topic should have applied, or should be able to apply what they have learnt to a workplace situation and will be able to alter their practices to the different contexts they are applying their learning to. Assessors should be confident that the learner's understanding is embedded in their practices and behaviour.

#### **Outcome 1**

Demonstrate understanding of requirements for handling lambs in a meat processing operation.

#### Performance criteria

- 1.1 Describe at least seven features of enclosures that inhibit stock handling and movement.
- 1.2 Describe the techniques for moving animals in enclosures.
- 1.3 Describe the characteristics of young animal behaviour, moving animal behaviour and sick animal behaviour.
- 1.4 Demonstrate at least four techniques that enhance operator safety in enclosures.

#### Outcome 2

Examine lambs in enclosures in a meat processing operation.

#### Performance criteria

- 2.1 Examine animals closely consistent with ante-mortem examination procedures.
- 2.2 Prepare and use ante-mortem examination equipment.
- 2.3 Apply ear tags where required.

Detect and diagnose diseases and defects in lambs, make judgements and apply dispositions to examined animals in a meat processing operation.

- 3.2 Make judgements on ante-mortem examination findings, and apply dispositions to inspected animals.
