<b>Purpose</b>	<p>This unit standard is for people who are employed in a meat processing operation to carry out ante-mortem examinations of sheep or goats used for human consumption.</p> <p>People credited with this unit standard are able to describe requirements for sheep or goat handling in a meat processing operation; examine sheep or goats in enclosures in a meat processing operation; and detect and determine diseases and defects found at ante-mortem examination of sheep or goats, and apply the dispositions.</p>

### 3 Definitions

*Dispositions* – action of ensuring examined animal material that has abnormalities is managed in accordance with legislative requirements.

*Workplace procedures* – the verbal and written policies and procedures on safety and operation set by the employer or organisation.

### 4 Assessment

In the context of this unit standard, the term *describe* means the learner can demonstrate this knowledge using a variety of means (written, diagrams, showing the assessor, verbal) provided there is documented evidence. A learner with a good understanding of a topic should have applied or should be able to apply what they have learnt to a workplace situation and will be able to alter their practices to the different contexts they are applying their learning to. Assessors should be confident that the learner's understanding is embedded in their practices and behaviour.

## Outcomes and performance criteria

### Outcome 1

Describe requirements for sheep or goat handling in a meat processing operation.

#### Performance criteria

- 1.1 Features of enclosures that inhibit stock handling and movement are described.
- 1.2 Techniques for safely handling and moving animals in enclosures are described.
- 1.3 Behaviours exhibited by sick or injured animals when moving are described.
- 1.4 Techniques that enhance operator safety in enclosures are described.

### Outcome 2

Examine sheep or goats in enclosures in a meat processing operation.

#### Performance criteria

- 2.1 Animals are examined consistent with ante-mortem examination procedures.
- 2.2 Ante-mortem examination equipment is prepared and used.

### Outcome 3

Detect and determine diseases and defects found at ante-mortem examination of sheep or goats and apply the dispositions.

**Performance criteria**

- 3.1 Diseases and defects are detected and determined during ante-mortem examination.
- 3.2 Dispositions to inspected animals are applied.
