Dispositions – action of ensuring that examined animal material or animal product with abnormalities is managed in accordance with legislative requirements.

Workplace procedures – the verbal and written policies and procedures on safety and operation set down by the employer or organisation.

Diagnose and assess diseases and defects found at post-mortem examination of bovines, make judgements and apply dispositions.

- 2.1 Diagnose and record diseases and defects affecting viscera and carcasses.
- 2.2 Make judgements on findings.
- 2.3 Apply dispositions to inspected animal products.
