Workplace procedures – the verbal and written policies and procedures on safety and operation set down by the employer or organisation.

Outcomes and performance criteria

Outcome 1

Carry out post-mortem examination of the heads and tongues of bobby calves for human consumption.

- 2.2 Make judgements on findings.
- 2.3 Apply dispositions to inspected animal products.
