*Workplace procedures* – the verbal and written policies and procedures on safety and operation set down by the employer or organisation.

Diagnose and assess diseases and defects found at post-mortem examination of heads and tongues, make judgements and apply dispositions.

- 2.1 Diagnose and record diseases and defects affecting heads and tongues.
- 2.2 Make judgements on findings.
- 2.3 Apply dispositions to inspected animal products.
