Outcome 1

Demonstrate high personal skiing competence to enable safe and effective intermediate snowsport instruction.

Performance criteria

- 1.1 Demonstrate dynamic medium radius parallel turns and basic parallel short turns on all groomed terrain.
- 1.2 Demonstrate competent ski performance using efficient and coordinated movements, both on and off piste.
- 1.3 Demonstrate alpine skiing on off piste terrain at a snowsport area, at a speed that allows flowing and rhythmical parallel turns through variable snow conditions.
