- 1 All learning and assessment against this standard must be carried out in accordance with the following:

  - Caving Activity Safety Guideline published by WorkSafe New Zealand and subsequent updates;

## 2 Definitions

Current industry good practice means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and visitors.

Short vertical pitch means a single pitch up to 15 metres in height. *Gear* includes clothing and footwear.

1.1 Describe the range of gear and equipment commonly used for caving in New Zealand.

1.2 Demonstrate the effective use of gear and equipment, appropriate for the terrain, temperature and protection needed.

#### Outcome 2

Demonstrate personal caving skills for streamway caves and short vertical pitches to include a short vertical pitch.

# Performance criteria

2.1 Demonstrate personal caving skills in terms of efficient movement to maintain sure footing and technique.

2.2 Demonstrate personal water caving skills.

> sumps, swimming, wading, ducking and identifying high and low Range water marks.

- Demonstrate personal caving skills in terms of ascent and descent of ropes, 2.3 and the use of lanyards.
- 2.4 Construct, use and retrieve handline, traverse lines and tyrolean.

may include fixed or placed protection for anchors. Range

2.5 Construct and use belay systems.

> includes ascent, descent, locking off and safety back up for a short Range vertical pitch.

2.6 Construct and retrieve an abseil system on short vertical pitch.

- 2.7 Demonstrate the use of a personal safety system.
- 2.8 Navigate through bush to determine present position using a topographical map.
- 2.9 Navigate through caves to determine present position using a cave map.

#### Outcome 3

Demonstrate simple vertical rescue skills.

### Performance criteria

- 3.1 Demonstrate simple abseil rescue to include a stuck abseiler, jammed clothing or hair, and abseiling down to abseiler then assisting to ground.
- 3.2 Demonstrate vertical rescue skills for a tired climber.

Range must include a direct haul, 2:1 haul system, 3:1 haul system and counter balance.
