- 3 Trainees will be required to maintain personal physical capability to meet physical requirements of daily ski patrol.

Demonstrate professional behaviour while undertaking daily ski patrol duties.

- 1.1 Demonstrate effective communication, interpersonal skills and team work to support positive customer service, interdepartmental communication and effective ski patrol practice.
- 1.2 Undertake ski patrol duties in accordance with organisational values, policy and practices.
- 1.3 Demonstrate safe work practices and follow procedures within scope of practice as a ski patroller.
- 1.4 Respond to feedback and identify improvements for daily ski patrol practice.
- 1.5 Maintain confidentiality regarding guest accidents and occurrences during daily patrol duties.

Demonstrate specific knowledge of a snowsport area for ski patrolling.

## Performance criteria

2.1 Identify and describe geographic and artificial features of a snowsport area used in ski patrol daily routines.
