2 Definitions

Company requirements include the policy, procedures, and methodologies of the company. They include legislative and regulatory requirements that may apply across the company or to a specific site. Requirements are documented in the company health and safety plans, traffic management plans, contract work programmes, quality assurance programmes, policies, and procedural documents. Forest users may refer to iwi, principals, employers, workers on site, people on site or passing through, landowners, harvesting contractors, or transport companies. Job prescriptions are those given to the operator prior to undertaking a job. They may include site safety instructions, mapping information, contract drawings, and written memos.

Mana whenua refers to local people who have authority over the land in a particular area.

Mana whenua values refer to an understanding of mauri and the practical application of this knowledge in the appropriate context.

Outcomes and performance criteria

Outcome 1

Interpret job prescription requirements for a forestry earthworks site.

Performance criteria

- 1.1 Job prescription requirements are interpreted in terms of practical application and compliance issues to resolve prior to forestry earthworks taking place and in accordance with company requirements.
- 1.2 Job prescription requirements are interpreted in terms of the tasks allocated forest users on a forestry earthworks site in accordance with company requirements.
- Job prescription requirements are interpreted in terms of selected resources for a forestry earthworks site including materials, plant, and equipment.
- 1.4 Job prescription requirements are interpreted in terms of environmental requirements, requirements related to mana whenua values, and water management methods for a forestry earthworks site.
- 1.5 Any issues with job prescription requirements, including co-ordination, scheduling, or prioritising of site works that impact on tasks are explained and actions taken in accordance with company requirements.

Outcome 2

Confirm job prescription requirements for a forestry earthworks site.

Performance criteria

- 2.1 Job prescription requirements are explained and confirmed in terms of suitability for a forestry earthworks site including the type, structure, content, stability, and strength of the soil.
- Job prescription requirements are explained and confirmed in terms of suitability of the construction method selections for a forestry earthworks site.
 - Range may include but is not limited to casting, end hauling, under cutting, benching.
- 2.3 Job prescription requirements are explained and confirmed in terms of landing specifications, start location, rural location points, site access, type of terrain, earthworks location and distances, and in accordance with forest user requirements.
- 2.4 Special features including bluffs, ridges, water courses and boundaries, and areas of historical or physical significance, or significance to mana whenua, are confirmed in terms of the impact on forestry earthworks.
- 2.5 Site hazards and emergency procedures are confirmed in accordance with job prescriptions.
