2 Definitions

Company requirements include the policy, procedures, and methodologies of the company. They include legislative and regulatory requirements that may apply across the company or to a specific site. Requirements are documented in the company health and safety plans, traffic management plans, contract work programmes, quality assurance programmes, policies, and procedural documents. *Forest users* may refer to iwi, principals, employers, workers on site, people on site or passing through, landowners, harvesting contractors, or transport companies. *Work plan* refers to any job specifications or plans given to the operator prior to undertaking the job.

Outcomes and performance criteria

Outcome 1

Communicate a work plan for forestry earthworks.

Performance criteria

- 1.1 Communication of the work plan to forest users onsite includes clearly stated objectives and language that fits the communication needs of each forest user.
- 1.2 Timelines for completion of the work plan are communicated to forest users and match the scheduling requirements.
- 1.3 Communications in meetings or briefings are planned and focus on quality outcomes and compliance in accordance with company requirements and client requirements.
- 1.4 Individual responsibilities for health and wellbeing are communicated and confirmed with forest users in accordance with company requirements.
- 1.5 Risk assessment, site safety, site safety plan requirements, including emergency procedures, are communicated to forest users prior to job commencement, and during job implementation, in accordance with company requirements.
 - Range communications may include but are not limited to tail gate meetings, site safety briefings.

Outcome 2

Coordinate forest users to complete a work plan for forestry earthworks.

Performance criteria

- 2.1 Forest users are selected for work tasks that match their ability, role requirements, responsibilities, and qualifications.
- 2.2 Attributes of a leader are explained in terms of assisting forest users to meet the requirements of a work plan.

- 2.3 Any rules and guidelines for behaviour of forest users are confirmed by consensus and meet company requirements.
- 2.4 Clarification, questioning and summarising are used to clarify issues, gain feedback, and respond to forest user concerns.
- 2.5 Documentation is completed in accordance with company and client requirements.
- 2.6 Results of quality checks and monitoring are used to provide feedback to forest users in accordance with company requirements.
- 2.7 Actions are taken to provide opportunities for active participation by all forest users during the phases of the work plan.
- 2.8 New ideas, work methods and opportunities are considered to redefine, avoid, or overcome conflict or obstacles.
- 2.9 Individual efforts, achievements, positive behaviours, and contributions that lead to quality outcomes, are acknowledged, and positive feedback is given in accordance with company requirements.
