Purpose	This unit standard is intended for people who can demonstrate knowledge and skills for single pitch rock climbing on routes up to Ewbank Grade 15.
	People credited with this unit standard are able to: demonstrate knowledge of rock climbing gear and equipment commonly used in New Zealand; demonstrate single pitch rock climbing skills on routes up to Ewbank Grade 15; demonstrate anchor construction for top rope climbing, and abseiling; and perform single pitch top rope and abseil rescues.

### 2 Definitions

Current industry good practice means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and visitors.

Gear includes clothing and footwear.

# Outcomes and performance criteria

### **Outcome 1**

Demonstrate knowledge of rock climbing gear and equipment commonly used in New Zealand.

#### Performance criteria

1.1 Describe the range of gear and equipment commonly used for rock climbing in New Zealand.

Range

type, characteristics, cost, care, maintenance, storage, and advantages and limitations;

may include but is not limited to – static rope, dynamic rope, tubular tape, abseil devices, prussik cord, harnesses, helmets,

karabiner types, belay devices.

1.2 Demonstrate the effective use of rock climbing gear and equipment that is appropriate to the location and season.

## Outcome 2

Demonstrate anchor construction for top rope climbing, and abseiling.

## Performance criteria

2.1 Construct a top rope climbing system and personal cliff top safety, linking multiple anchor points.

Range anchor points must include – placed or natural protection.

2.2 Construct an abseil system suitable for novice participants that is releasable.

Range anchor points must include – placed or natural protection.

2.3 Demonstrate use of passive protection, active protection and natural protection for anchor points.

### **Outcome 3**

Demonstrate single pitch rock climbing skills on routes up to Ewbank Grade 15.

### Performance criteria

- 3.1 Demonstrate single pitch rock climbing skills in terms of efficient movement on rock.
- 3.2 Demonstrate single pitch lead climbing skills required for a grade 15 sportclimbing route.
  - Range must include setting it up for top roping, cleaning the route and a personal cliff top safety when appropriate.
- 3.3 Demonstrate lead belaying using a belay device.
- 3.4 Demonstrate single pitch belaying for top roping using both a manual locking belay device and an assisted breaking belay device.

### Outcome 4

Perform single pitch top rope and abseil rescues.

#### Performance criteria

- 4.1 Perform a top rope rescue to take over a belay system and bring participant to the ground.
- 4.2 Perform a top rope rescue to bring a stuck climber to the ground.
- 4.3 Perform single pitch abseil rescue to deal with an upside down abseiler.
- 4.4 Perform a single pitch abseil rescue of an injured or stuck abseiler and assist them to ground.
- 4.5 Perform single pitch abseil rescues to unjam a descending device and a controlled lower of abseiler.
