 - relevant Activity Safety Guideline published by WorkSafe New Zealand and subsequent updates;

2 Definitions

Current industry good practice means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and visitors.

Gear includes clothing and footwear.

Outcomes and performance criteria

Outcome 1

Plan and prepare for single pitch top rope rock climbing and abseiling sessions.

Performance criteria

- 1.1 Use identified aims and objectives to develop an activity plan for guided or instructional top rope rock climbing and abseiling sessions.
- 1.2 Plan and prepare for safety and risk management of top rope rock climbing and abseiling sessions.

Range emergency routes, weather forecast, intentions, communication equipment and emergency response and contact information.

- 1.3 Prepare gear and equipment lists for the group and individual participants and make recommendations for individual nutrition and hydration requirements.
- 1.4 Justify emergency group equipment carried for a given rock climbing and abseiling session.
- 1.5 Explain the use of communication devices commonly used for rock climbing.

Outcome 2

Manage a group for a single pitch rock climbing and abseiling session.

Performance criteria

2.1 Prepare the group and carry out pre-trip briefing and checks.

Range includes – gear checks, disclosure of relevant medical information, hazards and procedure if guide or instructor or guide becomes incapacitated.

- 2.2 Assess individuals' rock climbing ability within the group and adapt session in response to the aims and objectives of the day.
- 2.3 Manage time in relation to planned activities, group and conditions.
- 2.4 Manage the group using guiding or instruction techniques and communication system.

- 2.5 Monitor and manage participants' behaviour, and apply a system to account for everyone.
- 2.6 Supervise and manage climbers, belayers, abseilers and the rest of the group.

Outcome 3

Apply effective group safety management for a single pitch top rope climbing session.

Performance criteria

- 3.1 Apply risk management strategies during a given rock climbing and abseil session and adjust plans when required.
- 3.2 Describe the assessment and management of an emergency situation including procedures for dealing with an incident or injury in the group.
- 3.3 Use a communication and safety checking system with participants during a rock climbing and abseil session.

Outcome 4

Apply knowledge of accepted environmental practices, knowledge and cultural awareness for rock climbing and abseiling in New Zealand.

Performance criteria

- 4.1 Role model the New Zealand Alpine Club (NZAC) code of conduct for rock climbers.
- 4.2 Role model respect for the environment through the personal application of environmentally sustainable principles.
 - Range includes respect for the tikanga and kawa of local iwi and/or hapū.
- 4.3 Manage and monitor physical, emotional, cultural and needs of the members of the group.
- 4.4 Interpret the natural and cultural history, geology, flora and fauna of a given rock climbing area for a group.
- 4.5 Describe the development of rock climbing as an outdoor recreation activity in terms of history, trends and development to a group.
- 4.6 Describe contemporary ethics and issues in the rock climbing environment.

Outcome 5

Evaluate single pitch rock climbing and abseiling sessions.

Performance criteria

5.1 Collect and evaluate feedback from a range of sources to identify areas of trip planning and management for improvement.

Range includes – self-review and external feedback.

5.2 Evaluate feedback and self-reflect on own performance to identify guiding or instruction aspects that could be developed.
