Guidance Information

- 1 *Reo Māori media* refers to the use of te reo Māori incorporating tikanga, and kaupapa Māori in the media.
- 2 Recommended for entry: Unit 30974, *Plan to deliver a live outside commentary in te reo Māori*.
- 3 This unit standard can be assessed in a work-based environment, or in a training and education environment if simulated media and Māori culture conditions are provided, or in a combination of both environments.
- 4 Live commentaries include – sports events, cultural performances, tangihanga, hui mate, court proceedings. A minimum of two events is required to be covered.
- 5 Definitions
House style refers to the style of writing and/or speech in accordance with the kaupapa, and the iwi the kaupapa is relevant to.
Live outside broadcast refers to an off-site location which is inside or outside.
Language refers to aspects of te reo Māori such as te whakahua, te mita, te tangi, me te hāngai ki te kaupapa.
Structure refers to intro, outro, body of work.

Outcomes and performance criteria

Outcome 1

Deliver live outside broadcast commentary in te reo Māori.

Range commentaries for two events are required.

Performance criteria

- 1.1 The commentary includes appropriate use of language structure and pronunciation that meets house style and audience requirements.
- Range interpretation, impact, modulation, intonation, pace, articulation, voice inflection.
- 1.2 The commentary is in accordance with the guiding commentary notes in the plan.
- Range interest, clarity, coherence, timing, attention to detail, humour, sensitivity.
- 1.3 The commentary information is accurate and reliable.
- 1.4 The commentary receives feedback from the audience or encourages engagement with the audience. This may include via use of phone, email, written, visual, focus group.
- Range evidence of one is required.
- 1.5 Evaluate feedback from the audience to substantiate future commentaries.
- 1.6 The commentary is recorded for archives.
- Range cataloguing, meta-data (attribution, time, date, location), and storage.
