A specific purpose refers to an identified employment focus requiring investigation. Connections refer to similarities and differences in the selection of information, viewpoints, and/or approaches across texts in relation to the specific employment-related purpose.

Extended written text refers to text that merits two to three weeks of focus and is aligned with the complexity and range statements of this unit standard. Independently refers to learners reading a range of texts on their own, without teacher input beyond support with text selection to meet vocabulary and text type requirements.

Outcomes and performance criteria

Read and make connections across extended English language written texts independently in an employment context.

extended written text types may include but are not limited to reports, manuals, regulations, proposals, promotional materials;

at least four extended texts, at least two of which are of different text types.
