Guidance Information

- 1 Evidence presented for assessment against this unit standard must be consistent with safe working practices and be in accordance with applicable service information, and company requirements and legislative requirements.
- 2 Legislation, regulations and/or industry standards relevant to this unit standard include but are not limited to – the current version of the Health and Safety at Work Act 2015; Hazardous Substances and New Organisms Act 1996, Biosecurity Act 1993; Resource Management Act 1991; Regional council bylaws; and any subsequent amendments and replacements.
- 3 **Definitions**

Company requirements refer to instructions to staff on policy and procedures that are available in the workplace. These requirements may include – company policies and procedures, work instructions, product quality specifications and legislative requirements.

Damage or deficiencies noticed refers to damage that is clearly detectable and is significant enough, in terms of company policies and procedures, to report. Such damage or deficiencies may not necessarily have occurred during the current operation and/or be caused by the candidate.

Regulatory requirements, for the purpose of this unit standard, refer to applicable legislation, standards and codes.

Service information may include – technical information for a vehicle, machine, or product detailing operation; installation and servicing procedures; manufacturer instructions; technical terms and descriptions; and detailed illustrations.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of the environmental regulatory requirements relevant to port cleaning activities.

Performance criteria

- 1.1 Environmental regulatory organisations are identified for port cleaning activities.
- 1.2 The purpose of a resource consent under the Resource Management Act 1991 for port cleaning activities is explained.
- 1.3 The Biosecurity Act 1993 is explained in terms of its application to port cleaning activities.
- 1.4 Workplace procedures to ensure compliance with regulatory requirements for port cleaning activities are described.
- 1.5 The response, recording and reporting procedures for the event of a non-hazardous and hazardous spillage are described in terms of organisational requirements and environmental protection.
- 1.6 Consequences to the workplace of non-compliance with environmental regulatory requirements are described.

Outcome 2

Clean cargo handling machinery or equipment.

Performance criteria

- 2.1 Environmental controls for cleaning machinery or equipment are implemented.
- 2.2 Machinery or equipment are cleaned.
- 2.3 Any damage or deficiencies noticed with machinery or equipment are reported.
- 2.4 Completed work is recorded.

Outcome 3

Clean the surface of a wharf.

Performance criteria

- 3.1 Environmental consideration is given prior to cleaning the wharf, and controls are implemented if required.
- 3.2 The surface of the wharf is cleaned and any damage to the wharf or contamination of the environment is reported.

3.3 Completed work is recorded.
