<b>Purpose</b>	<p>This unit standard aligns with the New Zealand Certificate in Painting and Decorating – Specifications, developed on behalf of the painting and decorating industry to specify the skills and knowledge required to achieve the New Zealand Certificate in Painting and Decorating (Level 4) with strands in Specialised Spraying, Wallcoverings, and Specialised Coatings [Ref: 3568]. This unit standard is intended for those working in the painting and decorating industry.</p> <p>People credited with this unit standard are able to prepare and break down painting and decorating sites to the level required of a commercially competent painter and decorator.</p>

### Guidance Information

This unit standard is one of a family of standards that align with the *New Zealand Certificate in Painting and Decorating – Specifications* and should be read, interpreted and assessed in the context of those *Specifications* and the New Zealand Certificate in Painting and Decorating (Level 4) with strands in Specialised Spraying, Wallcoverings, and Specialised Coatings [Ref: 3568].

The overarching level of performance for the family of unit standards is commercial competence.

Commercial competence requires a candidate to be capable of consistently performing the requirements of the skill specification:

- to current regulatory, industry and commercial standards
- within a commercially viable timeframe
- in commercial environments
- without supervision
- in different and unfamiliar contexts.

The sufficiency of evidence required to demonstrate commercial competence against this unit standard is determined within the context of the family of unit standards aligned to the *Specifications*.

The assessor must be confident that the candidate is capable of applying the skills and knowledge included in this skill specification to the level, scope and complexity required to support the achievement of related skills included in the *Specifications*.

Commercial competence can only be demonstrated, and must be assessed, in the workplace.

The assessment of commercial competence must be corroborated and confirmed by a person who has current expertise in the painting and decorating trade and has had the opportunity to regularly observe the candidate in the workplace.

## **Skill specification and performance level guidance**

### **Skill specification**

Prepare and break down painting and decorating sites.

**Know** The requirements for setting up and breaking down a site for painting and decorating.

The requirements for, and methods of surface preparation.

**Do** Set up a site for painting and decorating.

Remove and refit doors directly affected by painting or decorating work.

Remove and refit door and window hardware directly affected by painting or decorating work.

Clean up and break down the site after job is finished.

### **Performance level guidance**

Setting up includes protecting the work of other trades and preparing surfaces for painting and decorating.

Surface preparation requirements and methods will vary according to the type and location of the substrate.

Coatings include paint (primers, undercoats and topcoats), stain and clear finishes.

Preparation of previously coated surfaces includes removing existing coatings or wallcoverings prior to painting, preparing existing coatings for re-painting, and preparing coated surfaces in between coats.
