Kaupapa refers to a theme, context, event, or purpose;

Project brief refers to a plan, proposal;

Taonga puoro refers to musical instruments that can be constructed using a range of simple tools and equipment; for example, saw, drill, chisel, pao, mallet, router, sandpaper; and include kōauau, pongāihu, poi āwhiowhio, hue puruhau, pūtangitangi, nguru, pōrutu.

- 7 Types of materials appropriate for these taonga puoro may include mataī, kauri, tōtara, and other soft wood, bone, clay, hue, uku.
- Akonga will keep a fully documented visual diary or workbook to assist with assessment and authenticity.

1.7 The project brief includes the integration of at least one other toi art form.

Range toi art forms may include but are not limited to – rāranga, whakairo, tukutuku, kōwhaiwhai, tā moko, toi ataata.
