# 2 Definition

*Organisational policies and procedures* refer to the operations manual or documented normal operating procedures at an aquatic facility that set out the way in which the facility will operate on a day-to-day basis.

### 3 Assessment

Competency in this unit standard must be demonstrated in a real swim teaching environment and cannot be simulated.

### 4 Range

Competence must be demonstrated for two specialised adult learner aquatic education programmes. Each programme must:

- consist of 10 consecutive lessons;
- be aimed at adult learners at a different stage of development (e.g. one programme for beginner learners and one programme for intermediate learners).

At least one of the specialised aquatic education programmes must be for a group of at least three learners.

5 The swim teacher candidate must be in the water with beginner learners during each lesson, and as required for intermediate or advanced learners.

# Outcomes and performance criteria

## Outcome 1

Plan and deliver specialised aquatic education programmes to develop confidence, swimming, and water safety in adult learners.

# Performance criteria

- 1.1 Plan and structure lessons to support a specialised aquatic education programme that develops confidence, swimming, and water safety in adult learners.
  - Range lesson plans include but are not limited to links to programme aims, swimming progressions and techniques, introduction to basic non-contact water rescue principles, developmental activities that suit the age and stage of learners.
- 1.2 Apply knowledge of principles of friction, posture and propulsion and how they affect swimmers to select, use, and modify teaching techniques and strategies that meet the holistic needs of adult learners, and to meet the objectives of the lesson plans.
  - Range needs of adult learners include but are not limited to those related to learner goals and expectations, learner prior knowledge and skills in the water (stage of development), health and fitness, past swimming or water environment experience.
- 1.3 Select, use, and adapt equipment and resources to suit the needs of adult learners, and to meet the objectives of the lesson plans.
- 1.4 Provide clear information and instruction, confirm understanding, and receive feedback using communication techniques that are suited to learners, and to meet the objectives of the lesson plans.

# Outcome 2

Evaluate the delivery and implementation of the specialised aquatic education programmes.

# Performance criteria

2.1 Evaluate the effectiveness of the overall delivery and implementation of the specialised aquatic education programme.

2.2 Evaluate own performance as a swim teacher during delivery and implementation of the specialised aquatic education programme, and identify strategies to address any areas needing improvement.
