2 Definitions

Organisational policies and procedures refer to the operations manual or documented normal operating procedures at an aquatic facility that set out the way in which the facility will operate on a day-to-day basis.

Stroke techniques refer to biomechanical principles applied to improve the technical efficiency and effectiveness of strokes.

3 Assessment

Competency in this unit standard must be demonstrated in a real swim teaching environment and cannot be simulated.

4 Range

Competence must be demonstrated for two specialised aquatic education programmes. Each programme must:

- consist of 10 consecutive sessions;
- cover all four strokes, starts, and turns.

Both of the specialised aquatic education programmes must be for a group of at least six swimmers.

Outcomes and performance criteria

Outcome 1

Plan and deliver specialised aquatic education programmes to improve stroke techniques and the performance of swimmers.

Performance criteria

1.1 Plan and structure sessions to support a specialised aquatic education programme that improves stroke techniques and the performance of swimmers.

Range session plans include but are not limited to – links to programme

aims, assessment of each swimmer's readiness to acquire the relevant skills, teaching of efficient and effective stroke techniques.

- 1.2 Apply knowledge of instructional styles, basic biomechanical principles of strokes, external influences, and conditions to select, use, and modify teaching techniques and strategies that meet the needs of swimmers, and to meet the objectives of the session plans.
- 1.3 Select, use, and adapt equipment and resources to meet the needs of the aquatic education programme and swimmers, and the objectives of the session plans.
- 1.4 Provide clear information and instruction, confirm understanding, and receive feedback using communication techniques that are suited to each swimmer, and to meet the objectives of the session plans.

Range

includes – constructive and targeted feedback on efficient and effective stroke technique for each swimmer based on observation and monitoring.

Outcome 2

Evaluate the delivery and implementation of specialised aquatic education programmes.

Performance criteria

- 2.1 Evaluate the effectiveness of the overall delivery and implementation of the specialised aquatic education programme.
- 2.2 Evaluate own performance as a swim teacher during delivery and implementation of the specialised aquatic education programme, and identify strategies to address any areas needing improvement.
