## Guidance Information

- 1 All learning and assessment against this standard must be carried out in accordance with the following:
  - relevant legislation including Health and Safety at Work Act 2015 and Human Rights Act 1993, Vulnerable Children’s Act 2014, and The Health and Safety at Work (Adventure Activities) Regulations 2016;
  - *The New Zealand Curriculum* and/or *Te Marautanga o Aotearoa*; EOTC Guidelines – Bringing the Curriculum Alive 2016;
  - industry Codes of Conduct, the Outdoor Safety Code and ‘Leave No Trace’ principles;
  - a recognised and approved safety management system including organisational policies and procedures including Emergency Action Plans (EAPs), Standard Operating Procedures (SOPs), incident response management plans and the use of personal protective equipment (PPE);
  - current industry good practice.
  
- 2 Definitions
 

*Current industry good practice* means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and visitors.

*EOTC* means Education Outside The Classroom and, for the purposes of this unit standard, must be undertaken within an outdoor setting.

*EOTC activity* means a single activity, such as a rocky shore or geography field trip.

*Wellbeing* refers to health, behavioural and/or cultural needs of the participants.

## Outcomes and performance criteria

### Outcome 1

Demonstrate effective group and safety management for an EOTC activity.

#### Performance criteria

- 1.1 Demonstrate activity safety practices to students.
- Range includes but is not limited to – leaving activity intentions; briefing any activity assistants on their role, risk management and emergency procedures.
- 1.2 Use leadership strategies to engage, encourage and motivate students.
- Range may include but is not limited to – rapport building, giving instructions, language, body language, leadership style, teaching style.
- 1.3 Use techniques and strategies to demonstrate management of group.
- Range may include but is not limited to – safety briefings, boundaries, allocation of assistants.
- 1.4 Monitor students' food and drink intake and respond as required.

### Outcome 2

Lead a group and facilitate student learning for an EOTC activity.

#### Performance criteria

- 2.1 Perform a student briefing for an EOTC activity.
- Range includes safety considerations for activity, getting any student information updated, student gear checks, group gear, nutritional and hydration needs.
- 2.2 Use teaching strategies to facilitate learning outcomes for planned EOTC activity.
- 2.3 Deliver the lesson plan to meet student needs, adapting as required.
- 2.4 Manage time for group appropriately in accordance with activity and lesson plan requirements.
- 2.5 Deploy supervision structure as planned for activity.
- 2.6 Adjust activity to respond to any changes in weather as required.

**Outcome 3**

Demonstrate understanding of accepted environmental practices and cultural awareness.

**Performance criteria**

- 3.1 Follow minimal impact and sustainable practices.
- 3.2 Respond to the emotional, cultural and learning needs of the group.
- 3.3 Demonstrate respect for the environment through the personal application of environmentally sustainable principles.

Range includes – respect for the tikanga of local iwi and/or hapū.

**Outcome 4**

Evaluate an EOTC activity.

**Performance criteria**

- 4.1 Evaluate activity plan to identify areas of success and areas for improvement.

Range may include but is not limited to – logistics, timings, choice of activity, location for activity, safety planning and organisation's safety management system.

- 4.2 Evaluate the success of the EOTC activity in terms of the achievement of learning outcomes and student needs being met.
- 4.3 Reflect on own performance as an activity leader to identify areas of success and areas for improvement.
- 4.4 Create recommendations for future EOTC activities from evaluation and reflections.
