 - plaited cords are identical in pattern and length;
 - tassels are identical in proportion;
 - detailed knowledge of contemporary poi and the construction stages are recorded.

- 4 Demonstrate comprehensive knowledge and artistic skills to produce contemporary poi will be evidenced through:
 - plaited cords maintain a tight and balanced tension;
 - cords and tassels are secured in a manner that enhances overall design and functionality;
 - comprehensive knowledge of contemporary poi and the construction stages are recorded.
- 5 Ākonga will keep a documented visual diary or workbook to assist with assessment and authenticity.
- 6 Definitions

Contemporary refers to synthetic man-made materials.

Length ensures materials are of sufficient lengths to complete each poi.

Performance refers to a solo or group performance, for the testing of poi secureness and functionality.

Quantity ensures sufficient amounts of materials are prepared to complete each poi. Te Whare Pora – a house or place that is set aside to teach and conserve the art of weaving.

All sources of information must be referenced. Referencing will prepare ākonga for the requirements of academic writing.
