#### **Guidance Information**

This unit standard is one of a family of standards that align with the *New Zealand Certificate in Interior Linings Installation* – *Specifications* and should be read, interpreted and assessed in the context of those *Specifications* and the New Zealand Certificate in Interior Linings Installation (Level 4) with strands in Fixing and Finishing (with optional strand in Fibrous Plaster Installation) [Ref: 3061].

The overarching level of performance for the family of unit standards is commercial competence.

Commercial competence requires a candidate to be capable of consistently performing the requirements of the unit specification:

- to current regulatory, industry and commercial standards
- within a commercially viable timeframe

- in different and unfamiliar contexts.

Commercial competence can only be demonstrated, and must be assessed, in the workplace.

The assessment of commercial competence must be corroborated and confirmed by a person who has current expertise in the interior linings installation trade and has had the opportunity to regularly observe the candidate in the workplace.
