It will follow guidelines set by the relevant world body of their sport in terms of participation, playing guidelines and regulations and any other statutory requirements. *Rules* relate to the rules and regulations of the sporting code used for assessment and also the rules and regulations of the sporting event used for assessment.

- 1.1 Identify organisations that provide information for a selected sport.
 - Range information may include but is not limited to codes of conduct, rules, regulations, fair play, sideline behaviour initiatives.
- 1.2 Identify key organisations within a selected area of sport and describe their roles and responsibilities.
 - Range may include but is not limited to national sport organisations, regional sport organisations.

1.3 Identify external organisations that can provide support to a selected sport and describe their contribution.

Range may include but is not limited to – Sport New Zealand, Accident Compensation Corporation (ACC).

Outcome 2

Explain the rules and formats for a selected sport.

Performance criteria

- 2.1 Identify the rules, and describe how and when they are applied for a selected sport.
- 2.2 Identify when rule and regulation variations apply to specific sport communities, in accordance with the national sport organisation's requirements.
 - Range may include but is not limited to equipment, participant eligibility (e.g. age, gender, weight), distances or dimensions, format, timing, technique, tactical considerations, number of participants, rotations or replacements.
- 2.3 Describe different competition formats within a selected sport.

Range may include but is not limited to – knock out, seedings, round robin, handicap, round to round progression, semi-final to finals, points.
