# Outcomes and performance criteria

### **Outcome 1**

Depower electric vehicles.

#### Performance criteria

- 1.1 LV supply is disconnected and the proximity key is removed and secured.
- 1.2 HV service plug or manual service disconnect is removed to depower the HV system.
- 1.3 HV system is measured for zero residual AC and DC voltage.

### Outcome 2

Reinitialise electric vehicles.

#### Performance criteria

- 2.1 HV service plug or manual service disconnect is reconnected.
- 2.2 LV supply is reconnected and the system is powered up.
- 2.3 Diagnostic test equipment is used to check and recalibrate sub-systems affected by the depower process.
- 2.4 Post-reactivation faults are recorded.
