Implement environmental controls refer to the communication of plans and procedures for control of environmental risks and mitigation of environmental incidents, and either carrying out, or checking that the plans and procedures are carried out.

Industry requirements refer to relevant policies, processes, methodologies, industry codes of practice, site specific health and safety plans, standard operating procedures, site safety plans, quality plans, work plans, traffic management plans, contract work programmes, job safety analysis, safe work method statements, job instructions, manufacturer's requirements, contract specifications, manuals, procedural documents.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of environmental controls for an infrastructure worksite.

Performance criteria

- 1.1 Environmental controls for an infrastructure worksite are explained in terms of the consequences of non-compliance.
- 1.2 Environmental controls for the worksite are identified and explained in accordance with contract specifications.
- 1.3 Procedures for dealing with discovery of archaeological and contaminated sites are explained.

Outcome 2

Implement environmental controls for an infrastructure worksite.

Performance criteria

- 2.1 Resource consents and permits required for an infrastructure worksite are checked and confirmed in accordance with contract specifications.
- 2.2 Trees, watercourses, and other features of the surrounding environment are protected and monitored.
- 2.3 Controls for risks of discharge to water, soil, and air are carried out and monitored in accordance with contract specifications.
- 2.4 Spill prevention and management procedures are completed and monitored.
- 2.5 Controls to minimise public disturbance are carried out and monitored.
- 2.6 Incidents of environmental non-compliance are reported to relevant personnel.
