- 1.2 Carry out a routine for hands-on and visual examination of the entire body to determine the presence of any abnormality.
 - Range nose, eyes, ears, teeth, coat and skin, posture, nails or claws, feet, limbs, genitals, presence of wounds, abnormal swellings or lumps, mucous membrane colour; may include – sex.
- 1.3 Record and report normal or any variations to normal health and behaviour.

Outcome 2

Describe normal body temperature, pulse rate, and respiration, and significance of variations to normal for the companion animal.

Performance criteria

2.1 Describe normal body temperature, pulse rate, and respiration for an animal.

2.2 Describe the significance of variations to normal for the animal.
