Performance criteria

- 1.1 Scope and method of excavation, trench shoring, and reinstatement requirements are determined and confirmed from plan in accordance with contract specifications and company requirements.
- 1.2 Plant and equipment is selected in accordance with excavation method and company requirements.
- 1.3 Site management and communication requirements are identified and confirmed as in place before commencement of work.

Outcome 2

Carry out excavation work for pipeline construction or maintenance.

Performance criteria

2.1 Trench is set-out in accordance with contract specifications and company requirements.

Range depth, gradient, horizontal alignment.

- 2.2 Any required shoring is carried out to ensure trench does not collapse, in accordance with company requirements.
- 2.3 Excavation is carried out to achieve required depth, gradient, and horizontal alignment in accordance with contract specifications and company requirements.

Outcome 3

Carry out post-excavation reinstatement for pipeline construction or maintenance.

Performance criteria

- 3.1 Bed preparation and trench backfilling are carried out in accordance with contract specifications and company requirements.
- 3.2 Compaction is carried out to achieve a uniform, stable density in accordance with contract specifications and company requirements.
- 3.3 Any required tests are arranged, results of testing are interpreted, and appropriate action is taken to ensure specified bearing strength is achieved.

Range site safety plan, environmental plan, any traffic management plan, services plan, notifications.

3.4 Trench surface is prepared for final reinstatement in accordance with contract specifications and company requirements.
