evidence of at least three is required.

1.2 Wear appropriate clothing that is the correct fit and colour.

Range at least two of – footwear, protective clothing, hat, mask.

- 1.3 Sanitise hands and footwear.
- 1.4 Carry out site entry procedures.

### Outcome 2

Enter and walk through a poultry shed.

#### Performance criteria

- 2.1 Open and close the poultry shed door.
- 2.2 Progress through the shed with minimal disturbance to the poultry.

Range speed, pauses, noise, light intensity, use of torch.

- 2.3 Move in a manner that ensures poultry do not crowd against barriers or in corners.
- 2.4 Take corrective action where required to prevent smothering.

# **Outcome 3**

Inspect poultry, the environment, and equipment, and record environmental data.

#### Performance criteria

3.1 Check equipment for normal function, and identity, repair and/or report faults.

Range drinkers, feeders, lights, fans, heaters, cages.

3.2 Assess environmental conditions and take action where conditions are not consistent with workplace requirements.

Range temperature, air quality, light intensity, air speed.

- 3.3 Monitor feeding and drinking behaviour, and identify, correct, and report problems.
- 3.4 Remove, dispose of, and report dead poultry.

3.5 Identify, remove, dispose, record, and report cull poultry.

Range ill thrift, poor condition, injuries, deformities, out of production.
