2 Definition

Current industry good practice means the range of actions currently accepted within the adventure and outdoor sector (which includes the raft and riverboard industries) to manage the risk of harm to staff, participants, and visitors.

Outcomes and performance criteria

Outcome 1

Train and critique raft guides in raft guiding skills.

Performance criteria

1.1 Train raft guides in the delivery of safety briefings and in the instruction of the skills required to participate in the raft river trip.

Range must include – client screening;

may also include – foot entrapment, aggressive swim position, pull into raft, throw bag rescue, T-grip rescue, defensive float position, specific river hazards, river signals, raft flip potential.

- 1.2 Train raft guides in rapid management skills and techniques including on-river scouting, communication and signals.
- 1.3 Train raft guides in the use of river etiquette with other users.
- 1.4 Critique raft guides on their guiding performance and provide constructive feedback for improvements in their practice.

Outcome 2

Train and critique raft guides in river rescue.

Performance criteria

- 2.1 Train raft guides in whitewater rafting hazard and emergency management.
- 2.2 Train raft guides in rope systems and skills used in whitewater river rescue situations.

Range may include – anchors, rope rescue knots, bends and hitches.

2.3 Train raft guides in effective throw-bag rescues.

Range may include – deploying full length of throw bag accurately, 10 metre coil throw, static and dynamic belay technique.

2.4 Critique raft guides on their performance of river rescue skills and provide constructive feedback for improvements in their practice.

Outcome 3

Critique and update organisational safety and training procedures for rafting trips.

Performance criteria

- 3.1 Critique organisational river safety and training procedures.
- 3.2 Update hazard and risk procedures, risk register and training procedures in response to findings.
