Product specification refers to the documented requirements of the manufactured item.

Workplace policies and procedures refers to the documented procedures and policies providing guidelines of the tasks and activities carried out in the workplace. This typically includes relevant health and safety policies to eliminate hazard or risk in the workplace.

Outcomes and performance criteria

Outcome 1

Prepare materials and equipment to cure an item in an autoclave machine.

Performance criteria

- 1.1 Materials and equipment are prepared in accordance with product and process specification and workplace policies and procedures.
- Autoclave machine is calibrated in accordance with manufacturer's instructions 1.2 and workplace policies and procedures.

Outcome 2

Cure an item in an autoclave machine for composites.

Performance criteria

- 2.1 Materials are loaded into autoclave machine in accordance with process specification and workplace policies and procedures.
- 2.2 Cured item is unloaded from the autoclave machine in accordance with process specification and workplace policies and procedures.
- 2.3 Finished item is checked and remedial action is taken if required to ensure product specifications are met.
