Workplace policies and procedures refer to the documented procedures and policies providing guidelines of the tasks and activities carried out in the workplace. This typically includes relevant health and safety requirements to eliminate hazard/risk in the workplace.

Prepare materials and equipment to attach fixings and fastenings.

#### Performance criteria

1.1 Materials and equipment are prepared and matched to the requirements of the product specification.
