Guidance Information

- 1 Legislation, regulations, industry standards and codes of practice relevant to this unit standard include but are not limited to Health and Safety at Work Act 2015, New Zealand Road Code, and all subsequent amendments and replacements.
- 2 Assessment for this unit standard must use NZ Transport Agency and Certified Escort Riders New Zealand (CERNZ) approved assessors who hold a full Class 6 licence.
- 3 Definitions
Certified escort rider refers to a motorcycle rider who assists with the moving of an event along the roading network, holds a class 6 motorcycle licence, and unit standard 32007.
Company requirements refer to policy, procedures, and methodologies of the company. They include legislative and regulatory requirements that may apply across the company, to a specific worksite, or to a certified escort rider event. Requirements are documented in the company health and safety plans, traffic management plans (TMPs), contract work programmes, quality plans, policies, training methodology, operational and procedural documents.
- 4 Range
Evidence for two certified escort riding events is required to achieve this unit standard.

Outcomes and performance criteria

Outcome 1

Plan a certified escort rider event.

Performance criteria

- 1.1 Roles required for escorting a group, and motorcade positions are selected and explained in accordance with company requirements.
- Range a minimum of seven roles for the event.
- 1.2 Risk assessment is completed in accordance with the health and safety policy and procedures.
- 1.3 Motorcycle signage is selected in accordance with company requirements.
- 1.4 Chain of command during the live operation is established and confirmed in accordance with the requirements for the certified escort rider event.
- Range may include but is not limited to – road supervisor, lead rider, head trainer, certified escort rider, communications support, non-official cover (NOC), tail end charlie (TEC), support crew.
- 1.5 Practice schedule for the route is completed and any changes are recorded in accordance with company requirements.
- 1.6 Proposed route is confirmed, and event operational terms and conditions are explained in accordance with the health and safety policy and procedures and the code of practice for temporary traffic management (CoPTTM).

Outcome 2

Conduct a certified escort rider event.

Performance criteria

- 2.1 Proposed route is driven, route preparation procedures are followed, and any changes are documented in accordance with company requirements.
- Range route maps reviewed or accepted, communication systems requirements met, number of personnel confirmed, timing confirmed.
- 2.2 Parking requirements are managed during the event in accordance with company requirements.
- 2.3 Personal Protective Equipment (PPE) is worn, and appropriate equipment is used during the event in accordance with health and safety policy and procedures and company requirements.
- 2.4 Escort riding skills are demonstrated during the event in accordance with company procedures.
- 2.5 Pre-ride briefing is delivered in accordance with company procedures.

Outcome 3

Review a certified escort rider event.

Performance criteria

- 3.1 A debrief is completed for the event and feedback is recorded in accordance with company requirements.
- 3.2 Certified escort rider personal performance, technical and leadership skills are reviewed, and recommendations for improvements are recorded in accordance with company requirements.
