Outcomes and performance criteria

Outcome 1

Contribute to situational awareness as part of the Operations function for a CIMS response.

Performance criteria

1.1 Identify and analyse information to facilitate situational awareness for Operations.

Range evidence of four different pieces of information is required.

- 1.2 Provide a Status Report for Operations to facilitate situational awareness for the Coordination Centre.
- 1.3 Document key Operations decisions and actions throughout the incident response.

Outcome 2

Contribute to the planning process as part of the Operations function.

Range must include Action Plan and one other plan.

Performance criteria

2.1 Provide Operations input during Options Development and Options Analysis as part of the planning process.

Range

may include but is not limited to – field staff capability and capacity, support agencies capability and capacity, status of lifeline utilities, the community's response, current actions and progress, resource requirements and limitations, identifying critical resources, risk assessment, priorities:

evidence of four is required.

Outcome 3

Demonstrate knowledge of, and contribute to, the execution and monitoring of the Action Plan progress.

Range evidence of at least two Action Plans is required.

Performance criteria

3.1 Contribute to detailed task planning in accordance with the Action Plan.

3.2 Assign tasks to functions or response elements in accordance with the Action Plan.

Range

may include but is not limited to – delivering operational briefings, ensuring tasks are understood, record in a task register and location of assets, allocation of resources, integrating support agencies and stakeholders, amending task parameters.

3.3 Manage and monitor assigned tasks to support the execution of the Action Plan.

Range

may include but is not limited to – regular communication, resolving issues, ensuring operational aspects of health and safety is managed, maintaining a task register, maintaining optimal resourcing levels, forecasting resource needs, and escalating prioritisation and critical resource decisions to the Controller.

3.4 Modify the execution of the Action Plan in response to changes and opportunities in the situation.

Range

may include but is not limited to – resource allocation, task assignment, adjustment of coordination arrangements, risk mitigation, escalation.

3.5 Outline the processes for managing resource requests to support the execution of the Action Plan.

Range

must include but is not limited to – receipt of resource requests, comparing request against available resources and the Action Plan objectives, releasing resource or passing request to Logistics.

Outcome 4

Demonstrate knowledge of how Operations supports demobilisation and/or transition to recovery.

Performance criteria

4.1 Outline key aspects of Operations' role in demobilisation and/or the transition to recovery and explain why they are important.

Range evidence of four key aspects is required.
