Outcomes and performance criteria

Outcome 1

Review a design for an on-site wastewater management system.

Range evidence of two reviews of other people's designs is required.

Performance criteria

- 1.1 A design for an on-site wastewater management system is reviewed for completeness and suitability for the site in accordance with AS/NZS 1547:2012 or relevant guidelines issued by the Regional Council.
- 1.2 The design is checked for compliance with the provisions of G13 of the Building Code or relevant guidelines issued by the Regional Council.
- 1.3 The review is documented in the required format.

Outcome 2

Inspect an on-site wastewater management system.

Range evidence of one inspection is required, during construction just prior to completion.

Performance criteria

- 2.1 An on-site wastewater management system is inspected for compliance with the approved plans and specifications.
- 2.2 Variations to the approved plans and specifications are noted in the required format.

Range variations – minor, significant.

2.3 The as-built plans are reviewed for accuracy and completeness in accordance with AS/NZS 1547:2012.
