## 3 Definitions

Demonstrations refer to trial evaluations and prototypes of the Enabling Good Lives initiative in the community. They include the Waikato and Christchurch demonstrations, and MidCentral District Health Board's Mana Whaikaha. The Enabling Good Lives approach aims to increase the choice and control that disabled people and their whanau have in their lives and supports. It has five key characteristics – self-directed planning and facilitation; cross-government individualised and portable funding; considering the person in their wider context; strengthening families or whānau, and community building to develop natural supports.
