- 2 **Definition**
Production or event includes but are not limited to – events, performances, conferences, large meetings, film and television, broadcasts, livestream, concerts, stage shows, theatre, studios, dance shows, cultural performance, sporting events, music performances, competitive events, circus, festivals, trade shows, and exhibitions. May be inside or outdoors.

Outcomes and performance criteria

Outcome 1

Interpret the scenic construction requirements for a production or event.

Performance criteria

- 1.1 Demonstrate knowledge of scenic construction requirements for a production or event.
- 1.2 Negotiate any changes to scenic construction requirements to meet operational needs of the production or event.

Range may include but is not limited to – budget, transport or venue constraints, equipment availability, construction methodology, materials and finishing, timing, safety, crew.

Outcome 2

Plan for the scenic construction requirements for a production or event.

Performance criteria

- 2.1 Select resources to meet the scenic construction requirements and safety considerations for a production or event.
- 2.2 Produce documentation required to support the implementation of the scenic construction requirements.

Range may include but is not limited to – plans, schedules, cut list, equipment list, set construction drawings, finishing details.

Outcome 3

Prepare to implement the scenic construction requirements for a production or event.

Performance criteria

- 3.1 Supervise preparation of set construction resources for a production or event.
- 3.2 Coordinate the safe and effective transport of set construction resources to production or event space or venue.
- 3.3 Respond to any issues that arise during the preparation or transport of the scenic construction resources.

Outcome 4

Discuss the health and safety considerations in relation to the scenic construction requirements for a production or event.

Performance criteria

- 4.1 Discuss required equipment inspection and testing requirements, any regulatory issues, health and safety issues directly relating to the use of the set during rehearsals and/or performance.
- 4.2 Document the safe work methodology for the implementation of the scenic construction requirements.

Range may include but is not limited to – construction, transport, installation, and removal.
