Guidance Information

1 Assessment

This unit standard is intended to align with the *New Zealand Certificate in Concrete Production* – *Specifications* and the New Zealand Certificate in Concrete Production (Level 4) [Ref: 4187].

Evidence for this standard must reflect commercial competence.

Commercial competence refers to the ability to demonstrate knowledge and skills in the context of the currently accepted requirements of a business operating in a commercial environment.

Commercial competence must be confirmed by a person with current expertise in concrete production.

2 Definitions

The *Plant Audit Scheme* sets out the operating regulations and practices for each production plant, so accreditation requirements are met with the Concrete NZ Readymix Sector Group.

Workplace procedures refers to the documented procedures specific to a workplace that set out the standards and required practices of that workplace.

Skill specification and performance level guidance

Skill specification

Demonstrate knowledge of concrete batching in a concrete production plant.

Knowledge

The compliance responsibilities of a batching operator to meet plant audit requirements.

The information required to batch concrete according to a specified mix design.

Range information includes production register, material supplies.

The batching and mixing sequence to produce concrete in a production plant.

The processes and requirements for testing free moisture content of materials used in concrete production.

How to adjust weights and volumes of constituents to meet concrete mix design.

The storage requirements to maintain usability of aggregate products.

How to recognise from visual checks that aggregates are out of tolerance and the required remedial action.

Range remedial actions include weighing and sieving.

How varying the constituents of concrete outside of tolerance can adversely affect the performance of concrete.

Range includes adding water, aggregate, admixtures, and admixtures.

How mixing times for fresh concrete in transit impact on the performance of concrete once it has been placed and cured.

The procedure for checking a batched concrete mix is within tolerance and how to balance or correct it.

Range checking includes visual assessment. correction includes – wet, dry.

The rules and procedures for reuse of returned concrete.

Performance level guidance

Performance must reflect plant audit scheme requirements, NZS 3104, and workplace procedures.
