3 Definitions

*Key* may include manual, electronic, or biometric.

Lock and unlock may involve either manual and/or electronic prison locks. Incidents may include finding contraband/exhibits, prisoner behaviour, prisoner management, prisoner safety/welfare, prison security, visitor incident. Organisational policies and procedures refer to the formal policies and procedures for a specific prison site and its activities, and which are consistent with its lead organisation. 4 All evidence provided must be in accordance with and comply with organisational policies and procedures.

# Outcomes and performance criteria

#### Outcome 1

Maintain the security of the prison environment.

#### Performance criteria

- 1.1 Apply lock and unlock practices and key security including reporting.
- 1.2 Conduct prison musters.
- 1.3 Safely and securely conduct searches and record search results, including unauthorised items, seized items, exhibits.
- 1.4 Conduct and report prison security checks.
- 1.5 Ensure visitor access is restricted to defined and authorised areas.
- 1.6 Ensure visitor safety while in the prison environment.

#### Outcome 2

Demonstrate and apply knowledge of personal safety in relation to self and others in a prison environment.

# Performance criteria

- 2.1 Identify unsafe situations that impact on self and others.
- 2.2 Implement actions to manage unsafe situations for self and others.
- 2.3 Describe gangs, impacts of their activity and behaviour, and reporting of activity or behaviour that poses a risk to a person or to a site.
- 2.4 Explain the importance of maintaining certification training in a prison environment.

# Outcome 3

Demonstrate and apply knowledge on response to incident in a prison environment.

# Performance criteria

- 3.1 Identify risks and take actions to reduce risks as required.
- 3.2 Respond to incident using relevant procedures.

- 3.3 Report the incident in the required format and timeframes.
- 3.4 Describe post incident procedures and the officer's role and responsibilities in terms of follow up.
