*Industry requirements* refer to relevant policies, processes, methodologies, industry codes of practice, site specific health and safety plans, standard operating procedures, site safety plans, quality plans, work plans, traffic management plans, contract work programmes, job safety analysis, safe work method statements, job instructions, manufacturer's requirements, contract specifications, manuals, procedural documents, Waka Kotahi New Zealand Transport Agency specifications and guidelines.

- 4 For bypasses that require entry to an access chamber or other confined space it is recommended that candidates hold credit for both Unit 17599, *Plan a confined space entry,* and Unit 18426, *Demonstrate knowledge of hazards associated with confined spaces.* Where this entry occurs on reticulated water systems candidates should also have credit for Unit 19207, *Work in a confined space in the infrastructure industry.*
- 5 It is recommended learners achieve Unit 38209, *Demonstrate knowledge of bypasses for pipeline construction and maintenance* or demonstrate equivalent knowledge and skills, before starting this unit standard.

## Outcome 1

Install, commission, and decommission bypasses for pipeline construction or maintenance.

#### Performance criteria

- 1.1 Plan is obtained, and method of bypass is determined and confirmed.
- 1.2 Plant, equipment, fittings, and materials are selected in accordance with method of bypass and company requirements.
- 1.3 Site management and communication requirements are determined and confirmed as in place before commencement of work.

Range site safety plan, environmental plan, any traffic management plan, notifications.

- 1.4 Hoses and bungs are installed in accordance with contract specifications and company requirements.
- 1.5 The bypass is commissioned, maintained and monitored in accordance with contract specifications and company requirements.
- 1.6 The bypass is decommissioned in accordance with job requirements and the site is restored as required in accordance with contract specifications.
