- 2 Definitions

Current industry good practice means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and others.

Manaakitanga in the context of this standard means demonstrating behaviours that show respect, generosity and care for others. Showing respect in this context means demonstrating inclusive behaviours such as active listening, respecting individual differences and supporting others.

Whanaungatanga in the context of this standard means the relationship and sense of close connection developed through shared experiences and working together which provides people with a sense of belonging.

Outcomes and performance criteria

Outcome 1

Demonstrate knowledge of factors that contribute to group performance in an outdoor activity.

Performance criteria

- 1.1 Describe factors that contribute to group performance in an outdoor activity.
- Range may include but is not limited to – communication, trust, respect, cooperation, personal responsibility, conflict.
- 1.2 Demonstrate manaakitanga in a group challenge.
- 1.3 Explain the relevance of whanaungatanga to group achievement.

Outcome 2

Apply knowledge of group processes while participating in an outdoor activity.

Performance criteria

- 2.1 Demonstrate strategies to meet personal and group needs.
- 2.2 Communicate constructively in a timely manner.
- Range may include but is not limited to – suggestions, needs.
- 2.3 Act on suggestions from others in a positive manner.
- Range suggestions may include but are not limited to – feedback.

Outcome 3

Evaluate personal contribution to the group performance in an outdoor activity.

Performance criteria

- 3.1 Contribute to review of group's performance of the activity.
- 3.2 Evaluate the impact of own actions on group performance.

- 3.3 Create a personal action plan for participating in future group activities based on self-reflection and feedback from others.
