4 Definitions

Current industry good practice means the range of actions currently accepted within the adventure and outdoor sector to manage the risk of harm to staff, participants, and others.

Moving water means either river sections with slow moving current and without obstacles or rapids, or lake or coastal waters with small swells or waves, and/or small to medium surf onto a beach.

Outcomes and performance criteria

Outcome 1

Demonstrate individual preparedness for paddling on moving water.

Performance criteria

- 1.1 Wear or carry clothing and footwear for comfort and protection in accordance with trip requirements for moving water.
- 1.2 Fit and adjust the craft and all personal safety equipment.

Outcome 2

Demonstrate paddling skills for craft on moving water.

Performance criteria

- 2.1 Demonstrate safe controlled launching and landing of craft on moving water.
- 2.2 Demonstrate stability and control of craft while paddling.
- 2.3 Use paddle strokes to efficiently manoeuvre a craft.

Range forward, turn left, turn right, stop.

Outcome 3

Demonstrate basic safety skills and rescues for paddling on moving water.

Performance criteria

- 3.1 Demonstrate safe practices at all times.
- 3.2 Respond appropriately to signals commonly used to communicate on moving water.
 - Range may include but is not limited to whistle, hand, paddle; at least three signals.

3.3 Demonstrate readiness for assisted rescue.

Range

may include but not limited to – holding paddle, holding the craft, being upstream or on the windward side of their craft, signalling for assistance.
