1.2 Educate a standardbred horse to accept mouthing gear, short and long reins, and monitor the psychological requirements of a horse when training.

Range includes but is not limited to – positive reinforcement, taking into

account horse's attention span.

- 1.3 Introduce and educate a standardbred horse to the sulky and to being driven.
- 1.4 Educate a standardbred horse to gait.
- 1.5 Train a standardbred horse to a stage suitable for placing in a harness racing stable.
- 1.6 Monitor wellbeing of a standardbred horse during the education process.
