- 2.3 Remove dead, diseased, or pest infested wood.
- 2.4 Remove unsuitable branches or those not wanted for temporary fruiting wood.
- 2.5 Monitor, adjust, and remove training aids.
- 2.6 Remove, and dispose of, or mulch prunings.
- 2.7 Maintain record of training and pruning young trees.
