- 2 Definitions

Commercial fishing vessel refers to a vessel that is operating a Maritime Operator Safety System (MOSS) that is recognised by Maritime New Zealand and meets the requirements of the Maritime Transport Operator Certificate and/or Plan. *Environmental liaison programme* – primary objective to increase uptake of best practice mitigation onboard fishing vessels, by building relationships, assisting and educating fishers. The programmes are designed to identify and implement engineering and fleet operational solutions to address aquatic environmental issues including interactions with protected species e.g. Deepwater Group's Environmental Liaison Programme (DWG ELP) or the Department of Conservation Protected Species Liaison Officer project.

Industry operational plans – NPOA for Seabirds and NPOA for Sharks Protected Species Risk Management Plan (PRSMP) – vessel-specific documents that detail what mitigation of protected species is taken onboard a vessel reflecting the specific operations of the vessel, consistent with national policy and legislative requirements.

Workplace procedures refer to the policies and procedures set out in a verbal or written form by the employer or organisation. Procedures must be consistent with current legislative requirements and manufacturer's recommendations or instructions where relevant.

3 For the purposes of assessment all evidence must be presented in accordance with workplace procedures.

- 3.1 Complete and report a fishing vessel's specific PSRMPs.
- 3.2 Describe the process for reporting associated trigger events.
- 3.3 Describe the follow up process associated with trigger events as part of the environmental liaison programme.
- 3.4 Describe the audit processes associated with assessing a vessel's adherence specific to its PSRMPs.
