	 People credited with this unit standard are able to: assume control and organise an incident management team; develop an incident action plan (IAP) for vegetation fire incidents; implement the IAP for vegetation fire incidents; re-evaluate the IAP; and manage communications and reporting during vegetation fire incidents.

5 Definitions

Fire and emergency agency's requirements refer to policies, procedures and supporting documentation on safety and operations set down by each fire and emergency agency employer or host organisation. *Incident Action Plan (IAP)* is a statement of the objectives, strategies, and critical

functions to be taken at the incident.

6 Assessment against all outcomes must be in accordance with the fire and emergency agency's requirements.

Outcomes and performance criteria

Outcome 1

Assume control and organise an incident management team.

Performance criteria

- 1.1 Situation briefing and assumed incident controller position is received.
- 1.2 Current situation and determined immediate priorities are assessed.
- 1.3 Incident control protocols are established.
- 1.4 An incumbent incident management team is appointed.

Outcome 2

Develop an IAP for vegetation fire incidents.

Performance criteria

- 2.1 Data and information are collected and analysed.
 - Range fire plan, planning specialist advice, reports from incident management team.
- 2.2 Development of objectives, strategy and priorities is carried out in liaison with incident management team.
- 2.3 IAP is developed in accordance with the principles of CIMS.

Outcome 3

Implement the IAP for vegetation fire incidents.

Performance criteria

3.1 Incident managers are briefed with respect to the incident action plan.

Range fire suppression strategies, objectives of operation.

- 3.2 Incident is monitored and activities are recorded.
 - Range fire suppression achievements, coordination of activities, fire behaviour.
- 3.3 Planning meetings are held with the IAP team.
- 3.4 Planning for the ongoing IAP to cover fire ground mop up and patrol until the fire is declared out.
- 3.5 Operational costs are monitored and recorded against the IAP.

Outcome 4

Re-evaluate the IAP.

Performance criteria

- 4.1 The IAP is reviewed.
- 4.2 The IAP is revised as decided by the incident management team.
- 4.3 Demobilisation is planned and incorporated in the IAP.

Outcome 5

Manage communications and reporting during vegetation fire incidents.

Performance criteria

- 5.1 The communication plan is developed and maintained in accordance with the principles of CIMS.
- 5.2 Public announcements are provided.
- 5.3 Information for the incident report and incident debrief is provided.
