Guidance Information

- 1 Definition**

Legislative requirements refer to the obligations of the employer and/or employee under the Health and Safety at Work Act 2015 and Health (Hairdressers) Regulations 1980.

Workplace requirements mean the practices prescribed by management as being the quality standards for client contact and work organisation for a particular salon.
- 2 Range**

Heated styling tools are those used on dry hair and include but are not limited to – heated rollers, flat iron, curling irons, crimping irons.

Styles created must include – one hot tong set and one other look.

A commercially acceptable timeframe varies for different hairdressing services. A commercially acceptable timeframe to dress, finish, and apply product to hair is a maximum of forty-five minutes.
- 3** In this unit standard all work must comply with legislative requirements and must ensure optimum hair and scalp condition and maximum client comfort.

Outcomes and performance criteria

Outcome 1

Prepare to create a hairstyle that reflects current trends using heated styling tools.

Performance criteria

- 1.1 Service outcome is identified and confirmed in consultation with the client or in instructions from stylist, and client is protected for the required service in accordance with any manufacturer's instructions and the expectations of the salon environment.
- Range consultation must include – pre-quoting (time, money), time allowances, maintenance.
- 1.2 The hair and scalp are analysed.
- Range includes – porosity, elasticity, texture, density, length, scalp conditions, growth patterns, medical or other factors that can affect the skin.
- 1.3 A style is selected that is compatible with the hair and scalp analysis and confirmed service outcome.
- 1.4 The hair is prepared for styling in accordance with service outcome.
- 1.5 Tools are selected to meet the service outcome.
- Range includes – all required heated styling tools.

Outcome 2

Create a hairstyle that reflects current trends using heated styling tools.

Performance criteria

- 2.1 Heat protection products are selected and applied in accordance with manufacturer's instruction, hair analysis and service outcome.
- 2.2 Heated styling tools are used to commercial standards and manufacturer's instructions to meet the service outcome.
- 2.3 A style is created to meet the service outcome that demonstrates current trends.
- 2.4 Hair is dressed, finished, and product applied to meet the service outcome and to ensure maximum hair protection and completed within a commercially acceptable timeframe.
- 2.5 Safe handling procedures for electrical equipment are demonstrated in accordance with manufacturer's instruction (where available).

Outcome 3

Complete the service experience.

Performance criteria

- 3.1 Home haircare advice is provided and is consistent with client's hair type and style.
- Range includes – shampoo, conditioner and treatment product type; hair maintenance.
- 3.2 Client history is updated in accordance with workplace requirements.
- 3.3 Cleaning and maintenance procedures for electrical equipment is demonstrated in accordance with manufacturer's instructions and optimum performance and safety requirements.
- 3.4 Tools are sanitised and maintained in accordance with workplace requirements, and manufacturer's instructions.
- 3.5 The work areas are cleaned and tidied in accordance with workplace requirements.
