6 Reading

For the purposes of this unit standard, texts are written documents (not visual or oral). The reading texts must be of sufficient length and complexity to provide adequate evidence of competence. Suitable texts will require learners to use the skills outlined at koru/step 3 on the Read with Understanding strand of the Learning Progressions for Adult Literacy, or National Curriculum upper level 3/ lower level 4. At all times the quality of the texts, considered as a whole, is more important than length.

7 Writing

The texts must be of sufficient length and complexity to provide adequate evidence of competence: it is recommended that the texts total approximately 350 words. Nevertheless, at all times the quality of the writing, considered as a whole, is more important than its length. 'Sufficient complexity' refers to texts that demonstrate the writing demands outlined at koru/step 3 of the *Write to communicate* strand of the *Learning Progressions for Adult Literacy,* or National Curriculum upper level 3/ lower level 4.

Writing texts can be written in any method, including voice-to-text, and can be in any format and for any purpose.

The credits for this unit standard may not be used as evidence of literacy for NCEA purposes.
