- 2 Definitions

The *health and preventative health plan* refers to a workplace plan for managing all aspects of the day to day health and preventative health of horses in training in order to achieve performance objectives. The plan must be consistent with legislative requirements, rules and code of welfare. The equine health and preventative health plan must comply with health and safety legislation and be consistent with the workplace health and safety plan.

Workplace procedures – the procedures and standards set by the client or employing organisation. Workplace procedures should reflect current legislation.

- 3 Range

The learner must be provided with an existing equine health and preventative health plan which will be implemented and monitored by the learner to meet the requirements of this unit standard. The plan must include at least two performance objectives.

Implementation and monitoring of the health and preventative health plan must be for a period of at least six months for a minimum of four horses.

- 4 For the purposes of assessment evidence must be presented in accordance with workplace procedures.

- 5 All activities must consider manaakitanga, kaitiakitanga, kotahitanga, and whakawhanaungatanga that are valued in te ao Māori.

Outcomes and performance criteria

Outcome 1

Implement and monitor a plan for the on-going health and preventative health requirements for horses in training.

Performance criteria

- 1.1 Determine health and preventative health requirements from an equine health and preventative health plan.
- 1.2 Supervise workplace activities in accordance with the equine health and preventative health plan.
- 1.3 Monitor health and preventative health activities to ensure consistency with the plan.
- 1.4 Implement procedures to address health issues in accordance with the plan.
- 1.5 Record health and preventative activities in accordance with the plan.
- 1.6 Report on implementation of the equine health and preventative health plan.
