## Guidance Information

### 1 Assessment

This unit standard is one of a family of unit standards intended to align with the *New Zealand Diploma in Design (Kitchen Design/Bathroom Design/Light Commercial Design) (Level 5) – Specifications* and the *New Zealand Diploma in Design (Level 5)* with strands in Kitchen Design, and Bathroom Design (with optional strand in Light Commercial Design) [Ref: 3221].

The assessor must be confident that the candidate can apply the skills and knowledge included in this unit standard to the level, scope and complexity required to support the achievement of related skills included in the *Specifications*.

The overarching level of performance for this family of unit standards is professional competence as a light commercial kitchen or bathroom designer.

Professional competence requires the candidate to be capable of consistently performing the requirements of the skill specification in the context of light commercial kitchen or bathroom design:

- to current regulatory, industry best practice, and commercial standards, including:
  - Health and Safety at Work (General Risk and Workplace Management) Regulations 2014, available from [www.legislation.govt.nz](http://www.legislation.govt.nz);
  - The New Zealand Building Code, available from [www.building.govt.nz](http://www.building.govt.nz);
- to the ethical and professional expectations of industry and consumers
- while working autonomously
- in dynamic and varied contexts.

Evidence for assessment must include a minimum of two kitchen or bathroom design projects for new or existing light commercial spaces.

**2 Definition**

*Light commercial spaces* refer to multi-unit buildings such as apartment blocks and retirement villages, workplaces, cafes, schools, community, and cultural spaces.

**Skill specification and performance level guidance****Skill specification**

Apply legislative frameworks and implement compliance requirements for light commercial kitchen or bathroom design.

**Knowledge**

The health and safety legislative framework as it applies to the design of kitchens or bathrooms.

Range health and safety legislative framework regulations of relevance include – hygiene facilities, waste management, ventilation, egress, emergency exits.

The building legislative framework as it applies to the design of kitchens or bathrooms.

Range building legislative framework regulations of relevance from the Building Code include – accessibility, usability, flooring materials, lighting, fixtures, fittings.

The client protection legislative framework as it applies to the design of kitchens or bathrooms.

**Skills**

Assess and apply the relevant legislative frameworks in the context of kitchen or bathroom design.

Implement compliance requirements in the context of kitchen or bathroom design.

**Performance level guidance**

The legislative framework refers to the hierarchy of Acts of Parliament, Regulations, Rules, Codes, Standards, Approved Codes of Practice, and best/good practice guidelines as they apply to the kitchen and bathroom industry.

The level of performance must reflect current industry legislation, regulations, codes, standards, and best/good practice guidelines relevant to light commercial kitchen or bathroom design.
