Guidance Information

1 Assessment

This unit standard is one of a family of unit standards intended to align with the *New Zealand Diploma in Design (Kitchen Design/Bathroom Design/Light Commercial Design) (Level 5) – Specifications* and the New Zealand Diploma in Design (Level 5) with strands in Kitchen Design, and Bathroom Design (with optional strand in Light Commercial Design) [Ref: 3221].

The assessor must be confident that the candidate can apply the skills and knowledge included in this unit standard to the level, scope and complexity required to support the achievement of related skills included in the *Specifications*.

The overarching level of performance for this family of unit standards is professional competence as a light commercial kitchen or bathroom designer.

Professional competence requires the candidate to be capable of consistently performing the requirements of the skill specification in the context of light commercial kitchen or bathroom design:

- to current regulatory, industry best practice, and commercial standards, including:
 - Health and Safety at Work (General Risk and Workplace Management) Regulations 2014, available from www.legislation.govt.nz;
 - The New Zealand Building Code, available from www.building.govt.nz;
- to the ethical and professional expectations of industry and consumers
- while working autonomously
- in dynamic and varied contexts.

Evidence for assessment must include a minimum of two kitchen or bathroom design projects for new or existing light commercial spaces.

2 Definitions

Accessible refers to ergonomically designed kitchens or bathrooms suitable for a wide variety of users, including people with different kinds of impairments. Associated requirements refers to commercial grade products and materials, construction, renovation, and installation requirements, and relevant parties with which to communicate for the design of light commercial kitchens or bathrooms. Commercial grade refers to the required safety, quality, and legislative standards for use in commercial spaces. Design brief refers to the document that outlines the plan for a design project.

Design statement refers to a written summary of the final design.

Light commercial spaces refer to multi-unit buildings such as apartment blocks and retirement villages, workplaces, cafes, schools, community, and cultural spaces. Surface materials refer to materials for the surfaces of benches, doors and drawers, and walls and ceilings.

Develop and present kitchen or bathroom design concepts to meet the relevant design brief parameters for light commercial spaces.

recommendations, design statements, amendments to the construction or

renovation plan.

Provide advice on, specify and source relevant products and materials for light commercial kitchens or bathrooms.

Range may include commercial grade products and materials.

Create working drawings to a professional standard for light commercial kitchen or bathroom design projects.

fully dimensioned floor plan and elevations, electrical and lighting plan, Range

waterproofing plan, mechanical plan.

Gain approval from relevant parties to light commercial kitchen or bathroom design projects.

Performance level guidance

Mechanical plans include venting, heating, extraction, electrical and plumbing services, water supply, and waterproofing.

The level of performance must reflect current industry legislation, regulations, codes, standards, and best/good practice guidelines relevant to light commercial kitchen or bathroom design.
